_____ I hereby state I carefully reviewed this Service Agreement, and I acknowledge, recognize, appreciate, and assume all risks inherent in the sport of scuba diving and in the use of scuba diving equipment, particularly rebreathers, including risks of serious injury and death, and waive each and every claim for injuries, death, damages and losses, including claims for negligence and product liability which I may have against SubGravity and its employees, instructors, agents, and representatives, arising out of services performed or not performed under this Service Agreement.
